HURRICANE / TROPICAL STORM CLAIMS

We suggest that the insured use their best judgment in mitigating the loss by following the guidelines below.

PRE LOSS:

- Have procedures in place to protect employees.
- Make copies of critical records and contacts.
- Make sure employees know how to turn off utilities.
- Have emergency supplies available. Plywood, food & water, batteries, generators (and fuel and employees trained to safely use generators).
- Have an accurate accounting of assets, inventory and financial records.

POST LOSS:

- Take photos or make a videotape of damaged property.

Carrier Claims Contact Information

- Make temporary repairs to secure the business and / or prevent further damage. A good rule of thumb is to tell the insured to spend the money as if it was their own and no insurance was involved.
- Move valuables to a safe, dry location.
- Clean and dry everything that got wet with fans and dehumidifiers.
- Raise wall to wall carpets to allow air to circulate.
- Clean wooden furniture as quickly as possible. Give special care to antiques, paintings, art objects, silver and brass.
- Collect inventory records, appraisals and photographic records to help document the loss.
